

**CAMP FADECON 2018
WAIVER AND RELEASE OF LIABILITY**

I, the undersigned, hereby acknowledge that I desire to participate in the gaming tournament and exhibition held at the location of HILTON DALLAS/ROCKWALL LAKEFRONT 2055 SUMMER LEE DRIVE, ROCKWALL, TEXAS, 75032, on January 12 – 14, 2018 known as CAMP FADECON (“FADECON 2018”). I acknowledge that my decision to participate in FADECON 2018 is totally voluntary and is solely for the purpose of my pursuit of recreational activities that I enjoy. I am of sound judgment and capable of understanding the risks involved in participating in FADECON 2018.

I hereby assume all risk of illness or personal injury involved in FADECON 2018 in which I participate. For and in consideration of permission to participate in FADECON 2018, I hereby irrevocably and unconditionally forever release, discharge, indemnify, and hold harmless Clayton “FADE” Mulrey, FADECON, its affiliates, the sponsors of FADECON 2018, including the HILTON DALLAS/ROCKWALL LAKEFRONT, and each of their officers, directors, employees, stockholders, members and agents (each, a “Released Party”) from any and all claims, losses, causes of action and liabilities of any kind, including attorneys’ fees, (including but not limited to, actual, compensatory, and punitive damages), arising out of or relating in any way to FADECON 2018. I voluntarily waive any claims that I might have against any Released Party, and I understand and agree that the Released Parties assume no responsibility or liability for any injury to persons or property, or lost, stolen or damaged property, that may occur during or resulting from FADECON 2018. I further hereby agree that during FADECON 2018, I shall conduct myself in an appropriate fashion and I shall not behave poorly by performing harmful acts, using profanity, obscenity or any otherwise objectionable conduct towards any person or property involved with FADECON 2018 or the HILTON DALLAS/ROCKWALL LAKEFRONT. I recognize and understand that Clayton “FADE” Mulrey reserves the right to require cessation of any such activity and Clayton “FADE” Mulrey, in Clayton “FADE” Mulrey’s sole discretion, may require my removal from FADECON 2018.

I agree that I have read and will follow all official event and tournament rules, which are posted on the official FADECON web site <http://www.FADECON.org>. I understand media attending the event, Clayton “FADE” Mulrey and/or other Released Parties may take photos and/or videos of FADECON 2018 and in connection therewith, I hereby unconditionally authorize Clayton “FADE” Mulrey and such other Released Parties to use, reuse, and to grant others the right to use and reuse, in any media, my name, photograph, likeness, voice, and, if made available by me, my biographical information.
